Courtroom HVAC:

To Whom it May Concern:

Hall Heating and Air will replace existing furnaces, and install new air condition into courtroom.

Existing furnaces will be removed, and existing ductwork will be salvaged and reused. Filter bases will be installed into exiting return duct, and 2 new RunTru by Trane 80% efficient 100,000 BTU furnaces will be installed on filter bases.

New 5 ton RunTru by Trane evaporator coils will be installed on new furnaces and tied into existing supply ductwork.

A crane will be utilized to lift 2 new RunTru by Trane 5 ton condensers onto the roof of the courthouse. New copper line sets will be run down through the roof drains and into the mechanical closets to tie into the new evaporator coils.

Drains for the new cooling system will drain into the roof drains below the copper line sets.

2 new digital programmable thermostats will also be installed and utilized for proper control and functions of systems.

Safety upgrades: surge protection for both outdoor units, sediment traps for gas valves, carbon monoxide detection in court room.

Warranty information: 1 year parts, 5 year compressor, 20 year heat exchanger, and 1 year labor warranty on each of the new systems.

All pricing to complete job is as follows:

- 3. Structural steel support
- 4. Starters or disconnects and electrical power wiring or conduit
- 5. Any painting or roofing
- 6. Fire stopping, fire caulking, or fire protection
- 7. Certified commissioning
- 8. Warranty or service of existing equipment
- 9. Any provisions for relocating equipment on roof
- 10. Any gas line repairs, replacement or testing that does not include the new appliance connections. If we propose to alter or move a gas line please be aware that the proposal cannot include any unknowns of the existing gas line's integrity.
- 11. Landscaping after backfilling
- 12. Overtime rates including weekends or evenings or holiday work
- 13. Nail pops in ceiling from attic work or any type of dust control
