We will provide services 24 hours a day 7 days a week. Dispatching software through Towbooks can also provide an "uber" like experience with tracking the driver to location.

Strive to provide a response time of 30 minutes in the City of Claude; 1 minute per mile outside the city

Provide access to a fleet of 25 trucks and equipment arriving out of Amarillo and surrounding areas to assist when needed. We are looking to expand our fleet if the situation arises that we need to place more wreckers in the county.

Trucks are equipped with live 2-way cameras and GPS through Samsara.

Provide drivers who are proficient and competent in the operation of wreckers, towing and recovery. Drivers shall obey all state and traffic laws when responding and conduct themselves in a respectable and safe manner. They will abide by the regulations dictated by the Texas Department of Licensing and Regulations.

We would like to provide or participate in training with law enforcement and first responders in the county to assure safety by working as a team.

Our goal is to provide fast and efficient services with well trained employees to minimize the exposure of first responders on the roadway. We hope to bring jobs and be a part of your community.
