
NOTICE OF VOTER-APPROVAL TAX RATE ELECTION HAPPY INDEPENDENT SCHOOL DISTRICT

For all eligible District voters, voting on Election Day, November 7, 2023, will be conducted between the hours of 7:00 am and 7:00 pm at the polling places listed in Exhibit "B" attached hereto and incorporated herein by reference.

Election called the 14th day of August, 2023 and ballot certified the 5th day of September, 2023.
